Participates in needs assessment, research, design, and evaluation of statewide public safety training programs. Demonstrates teamwork and high degree of customer service.

Minimum Qualifications: Eighteen months of work experience as a full-time instructor of Emergency Communications related topics OR four years of recent work experience in Emergency Communications of which three years involved providing diversified training development and delivery applicable to Emergency Communications as an adjunct instructor on special assignment, in addition to the regular public safety duties.

Special Qualifications: Must have excellent writing, research, and computer skills. Must be able to perform research in a variety of mediums and develop lesson plans. Must possess strong interpersonal communication skills and have the ability to teach complex topics in a clear, concise and easily understandable manner.
