Description of Duties & Responsibilities: Under limited supervision, manages statewide public safety training operations and programs for a training section. Supervises professional staff in the development, review, and revision of training programs. Maintains all necessary accreditation for training programs. Oversees statewide training standards and requirements. Develops, administers, and monitors training budget. Coordinates training activities with department mission and operational requirements. Demonstrates teamwork and a high degree of customer service.

Position Requirements: Excellent communication, presentation, interpersonal, and leadership skills. Strong organizational and time-management abilities. Proficient in adult learning principles and instructional design. Knowledge of various management styles and theories. Skill in using Microsoft Office Suite, Google Workspace, and other technology. Occasional travel for off-site and overnight training to include other GPSTC locations may be required.

Minimum Qualifications: High school diploma or GED AND Five years of experience, Two years of which is at the supervisory or project leader level in planning, developing, implementing, and delivering P.O.S.T. certified (and/or Military Level) training and assisting with establishing program goals and objectives. Currently have a good standing status with Georgia Peace Officer Standards & Training and/or Georgia Fire Standards & Training.

Preferred Qualifications: Preference may be given to those applicants who, in addition to meeting the minimum training and experience requirements possess the certification of the Georgia POST Master Resiliency Instructor and possess 5 years of supervisory experience with any employer including responsibility for supervising day-to-day operations to include evaluating, motivating, and mentoring assigned staff.

Required Certifications: Must currently hold Georgia P.O.S.T. Instructor Certification as a General or Level 2 Instructor.
