Job Title: **Public Safety, Trainer 3 (Basic LE Training, GPSTC – Columbus)**

Starting Salary: \$61,858.00 - \$64,950.90 (\$5,154.80 - \$5,412.57 per month)

Description of Duties & Responsibilities: Under limited supervision, conducts classroom-based lecture and practical skills building sessions for Basic Mandate Law Enforcement training delivered throughout the year at a GPSTC regional academy. Participates in needs assessment, research, design, and evaluation of statewide public safety training programs. **Position Requirements:** Training delivery may require evening, early morning, weekend work. Position requires travel to assist in training delivery at satellite locations, other regional academies, and GPSTC main campus. Instructor of topics including firearms, defensive tactics, and driver training for law enforcement: Long periods of standing, riding, driving, bending, and squatting required. Year-round training in all weather conditions. Wearing of personal protective equipment, i.e., training suit used for defensive tactics training.

Minimum Qualifications: Eighteen months of work experience as an instructor providing training development and delivery in various law enforcement related topics. Possession of Georgia Peace Officer Standards and Training Basic Law Enforcement certification. Must currently hold a good standing status with Georgia P.O.S.T. **Preferred Qualifications:** Preference may be given to those applicants who have a minimum of four years' recent law enforcement work experience; have been regularly instructing in a law enforcement training program; have specialization in an advanced subject area applicable to basic LE mandate training; possess Georgia POST Certification as a General or Level 2 Instructor and any of the position required Georgia POST specialty instructor certifications.

Required Certifications: Must currently hold or must successfully obtain within 24 months of hire, a minimum of two (2) of the position-specific instructor certifications, e.g., Firearms, Driver Training, Defensive Tactics, Use of Force, etc. with no more than two attempts at each certification.
